WHEREAS, THE SIGNING OF THE SMITH-LEVER ACT ON MAY 8, 1914 ESTABLISHED COOPERATIVE EXTENSIONS AS THE INFORMATION EDUCATIONAL ARM OF THE LAND GRANT UNIVERSITIES. IN PENNSYLVANIA, PENN STATE UNIVERSITY WAS CHOSEN TO BE THE LAND GRANT UNIVERSITY BY THE DEPARTMENT OF AGRICULTURE; AND

WHEREAS, THE EXTENSION WAS FIRST ESTABLISHED IN CARBON COUNTY IN 1917 WITH THE ESTABLISHMENT OF THE CARBON COUNTY FARM BUREAU, WHICH THEN BECAME THE AGRICULTURAL EXTENSION ASSOCIATION OF CARBON COUNTY IN 1924; AND

WHEREAS, THE PRIMARY PURPOSE OF THE COOPERATIVE EXTENSION HAS BEEN TO DISSEMINATE AGRICULTURAL AND HOME ECONOMICS PROGRAMMING TO AUDIENCES FROM RURAL TO URBAN. SINCE ITS INCEPTION, THE CARBON COUNTY EXTENSION HAS HAD A POSITIVE IMPACT ON THE ADVANCEMENT OF AGRICULTURE, HOME ECONOMICS AND YOUTH DEVELOPMENT; AND

WHEREAS, AGRICULTURE IS AN IMPORTANT PART OF THE COOPERATIVE EXTENSION AND HAS GROWN TO INCLUDE FARMLAND PRESERVATION, WASTE DISPOSAL, WATER QUALITY, AND PESTICIDE SAFETY. THIS CLUB WAS THE PREDECESSOR OF TODAY'S CARBON COUNTY 4-H. 4-H PROGRAMMING INCLUDES DAIRY, POULTRY, FRUIT, VEGETABLE AND OTHER AGRICULTURAL MANAGEMENT PRACTICES. PRESENTLY, 4-H IS INVOLVED IN OVER 100 DIFFERENT PROJECTS, INCLUDING AGRICULTURE, HOME ECONOMICS, FORESTRY, WILDLIFE, AND LEADERSHIP SKILLS JUST TO NAME A FEW.

WHEREAS, THE COOPERATIVE EXTENSION WORKS WITH THE COMMUNITY TO ACQUIRE THE KNOWLEDGE, SKILLS AND MOTIVATION NEEDED TO THE PROFITABILITY OF ANIMAL AND PLANT PRODUCTION SYSTEMS, PROTECTS NATURAL RESOURCES, HELPS PEOPLE MAKE HEALTHY LIFESTYLE CHOICES, ENSURES A SAFE AND ABUNDANT FOOD SUPPLY, ENCOURAGES COMMUNITY VITALITY AND GROWS THE NEXT GENERATION OF LEADERS.

WHEREAS, THE BOROUGH OF BEAVER MEADOWS IS CELEBRATING THE 230TH ANNIVERSARY OF ITS FOUNDING, HAVING BEEN FORMED IN 1787 WHEN LAND WAS DEEDED AT THAT TIME TO THE LATE PATRICK AND MARY KEEN:

WHEREAS, THE BOROUGH IS CUT OUT OF A PORTION OF LAND OF WHAT WAS ONCE KNOWN AS ST. ANTHONY'S WILDERNESS, PART OF THE GREAT NORTHERN SWAMP TRAIL, COMING TO LIFE OUT OF A LAND TRANSACTION FROM NORTHAMPTON COUNTY, ONE OF THE ORIGINAL 3 COUNTIES OF PENNSYLVANIA, FORMED IN 1752:

WHEREAS, J.M. STAUFFER SUCCEEDED IN HAVING BEAVER MEADOWS CHARTERED AS A BOROUGH IN 1897, SOME 110 YEARS AFTER KEENE RECEIVED THE DEED;

WHEREAS, "THE MOTHER OF CARBON COUNTY" HAS A STORIED HISTORY THAT INCLUDES:

- THE DISCOVERY OF COAL THERE IN 1812 BY NATHAN BEACH.
- THE ESTABLISHMENT OF THE BEAVER MEADOW RAILROAD AND COAL COMPANY IN 1841;
- HOPKIN THOMAS, A WELSH ENGINEER AND MASTER MECHANIC, DEVELOPED A TOTALLY HARD-COAL OPERATED LOCOMOTIVE AND THE FIRST COLD-CURED STEEL LOCOMOTIVE WHEEL, BOTH BEING THE FIRST OF THEIR KINDS KIND IN THE COUNTRY.
- THE BOROUGH IS THE SITE OF THE FIRST STEAM-DRIVEN RAILROAD IN THE COUNTY.
- REUBAN DINKEY, A MASTER MECHANIC FOR THE BMRR, INVENTED AND DEVELOPED A SMALL ENGINE DESIGNED FOR LIGHT TRAFFIC CALLED THE "DINKEY ENGINE" IN THE SHOPS OF THE BEAVER MEADOW RAILROAD.
- BMRR WAS THE FIRST TO UTILIZE A GRAVITY-DRIVEN MINE DRAINAGE TUNNEL IN THE AREA. THIS TUNNEL SYSTEM IS STILL IN OPERATION AND CONTINUES TO RELIEVE WATER DRAINAGE FROM THE TOWN INTO THE STILL CREEK VALLEY.
- ST. MARY'S RC CHURCH IN 1808 BECAME THE FIRST CHARTERED CHURCH IN THE AREA.
- AND EARLY INDUSTRY IN THE TOWN INCLUDED A BREWERY, SHOE FACTORY, AND THE FIRST POWDER MILL AND SAW MILL IN THE REGION.
- ALSO NOTED IS THE LONG LINE OF MEN AND WOMEN WHO SERVED OUR COUNTRY IN TIME OF CONFLICT, INCLUDING WILLIAM H. WILSON, REVOLUTIONARY WAR HERO UNDER GEORGE WASHINGTON; AND THE BOROUGH WAS HOME TO OFFICERS AND INFANTRYMEN OF THE PENNSYLVANIA MINERS DIVISION OF THE NORTHERN ARMY DURING THE CIVIL WAR. THEY PLAYED AN INFLUENTIAL ROLE IN THE BATTLE OF THE CRATER, PETERSBURG, VA, WHERE PA. MINERS DUG A TUNNEL UNDER THE CONFEDERATE FRONT LINE AND BLEW IT UP.
