#17-318 FCSLA/125TH ANNIVERSARY:

MOTION BY MR. GERHARD, SECONDED BY MR. NOTHSTEIN, TO ADOPT THE FOLLOWING RESOLUTION RECOGNIZING THE 125TH ANNIVERSARY OF THE FIRST CATHOLIC SLOVAK LADIES ASSOCIATION (FCSLA):

WHEREAS, NINE SLOVAK IMMIGRANT WOMEN, UNDER THE LEADERSHIP OF MRS. ANNA HURBAN GATHERED AT ST. LADISLAUS CHURCH IN CLEVELAND, OHIO ON JANUARY 1, 1892 AND BEGAN LAYING THE FOUNDATION FOR A FRATERNAL BENEFIT SOCIETY, THE FIRST CATHOLIC SLOVAK LADIES UNION (FCSLU); AND

WHEREAS, THE FIRST CATHOLIC SLOVAK LADIES UNION WAS FOUNDED TO HELP MEET THE NEEDS OF IMMIGRANT FAMILIES BY ESTABLISHING PROVISIONS FOR DEATH AND INJURY BENEFITS THAT WOULD PROTECT FAMILIES FROM THE HAZARDS AND TOLL OF INDUSTRIAL LABOR; AND

WHEREAS, OVER THE NEXT FEW MONTHS, MANY MEMBERS WERE RECRUITED, BYLAWS WERE CREATED, AND BY THE YEAR END THE FCSLU HAD GROWN FROM \$77 IN ASSETS AND 9 MEMBERS TO \$212 IN ASSETS AND 95 MEMBERS; AND

WHEREAS, BY 1899, THE FCSLU HAD 1,859 MEMBERS WHO PAID 14 CENTS A MONTH AND THE ORGANIZATION BECAME CHARTERED IN THE STATE OF OHIO. FROM 1893 TO 1915, ASSETS AVERAGED AN 86 PERCENT INCREASE BIENNIALLY; AND

WHEREAS, IN THE LATE 1960'S, THE NAME WAS CHANGED TO THE FIRST CATHOLIC SLOVAK LADIES ASSOCIATION (FCSLA) TO AVOID CONFUSION OF THE TERM UNION; AND

WHEREAS, AS OF JUNE, 2017, FCSLA HAS REPORTED ASSETS THAT TOTAL OVER \$900 MILLION WITH OVER 100,000 MEMBERS ACROSS THE NATION, IS LICENSED TO PROVIDE INSURANCE PRODUCTS IN 48 STATES AND THE DISTRICT OF COLUMBIA, AND RANKS AMONG THE TOP FRATERNAL BENEFIT SOCIETIES; AND

WHEREAS, AS A FRATERNAL SOCIETY, THE FCSLA HAS OVER 450 BRANCHES ACROSS THE UNITED STATES. MEMBERS ARE INVOLVED IN CATHOLIC CHURCH AND RELATED EDUCATIONAL ACTIVITIES, CARE FOR OTHERS IN THE SOCIETY AND THE COMMUNITY, AND INVOLVE YOUNG PEOPLE IN ACTIVITIES. THE ASSOCIATION SPONSORS OVER \$248,000 IN SCHOLARSHIPS ANNUALLY.

NOW, THEREFORE, BE IT RESOLVED, THE MEMBERS OF THE BOARD OF COMMISSIONERS OF CARBON COUNTY HEREBY RECOGNIZE THE 125TH ANNIVERSARY OF THE FIRST CATHOLIC SLOVAK LADIES ASSOCIATION AND EXTEND THEIR CONGRATULATIONS TO THE ASSOCIATION ON THIS JOYOUS CELEBRATION.
