COMMISSIONER O'GUREK GAVE AN UPDATE ON THE LIFEGUARD SITUATION AT MAUCH CHUNK LAKE PARK, NOTING THERE ARE TWELVE (12) LIFEGUARD POSITIONS WITH ONLY SEVEN (7) POSITIONS FILLED AND TWO (2) PENDING. HE SAID THAT ANYONE GOING TO THE PARK ON A DAY WHEN NO SWIMMING IS ALLOWED DUE TO LACK OF LIFEGUARDS WILL RECEIVE A CREDIT.

COMMISSIONER NOTHSTEIN STATED THAT THE BIGGEST ISSUE IS THE COST OF LIFEGUARD TRAINING AND CPR CERTIFICATION, ADDING THAT THE COMMISSIONERS WILL BE DISCUSSING POSSIBLY GIVING AN INCENTIVE.
