AN ORDINANCE OF THE COUNTY OF CARBON, PENNSYLVANIA REVISING ORDINANCE NO. 1993-02 BY REVOKING AND REMOVING SECTION 26C IN ITS ENTIRETY AND RATIFYING ORDINANCE NO. 1993-02 IN OTHER RESPECTS AS IF REENACTED AT LENGTH:

WHEREAS, ON THE 14<sup>TH</sup> DAY OF OCTOBER 1993, THE BOARD OF COMMISSIONERS OF THE COUNTY OF CARBON DULY ENACTED ORDINANCE NO. 1993-02 ADOPTING RULES AND REGULATIONS FOR THE CARBON COUNTY DEPARTMENT OF PARKS AND RECREATION; AND,

WHEREAS SECTION 26 OF SAID ORDINANCE DEALS WITH ALCOHOLIC BEVERAGES; AND,

NOW, THEREFORE BE IT ORDAINED THAT THE BOARD OF COMMISSIONERS OF THE COUNTY OF CARBON, COMMONWEALTH OF PENNSYLVANIA DO HEREBY AMEND ORDINANCE NO. 1993-02 BY REMOVING SECTION 26C IN ITS ENTIRETY.
