- SENATE BILL 841 WILL ALLOW THE COUNTY TO POSSIBLY ELIMINATE THE PENALTIES; CURRENTLY FUNDING FOR THE COUNTY HAS NOT BEEN AVAILABLE DURING THE PANDEMIC.

COMMISSIONER LUKASEVICH COMMENTED ON THE FOLLOWING:

- CHALLENGES THE COUNTY WILL HAVE WITH THE BUDGET IN THE NEXT FISCAL YEAR DUE TO THE PANDEMIC.
- COVID GEODATA RECEIVED FROM THE PENNSYLVANIA DEPARTMENT OF HEALTH WHICH HAS BEEN PLACED IN THE 911 SYSTEM FOR FIRST RESPONDERS AND THOSE WHO HAVE THE AUTHORITY TO RECEIVE THE INFORMATION WHEN DISPATCHED IN THE COMMUNITY.
- SENATE BILL 841SIGNED BY GOVERNOR WOLF REGARDING THE OPTIONS AND THE CHALLENGES WITH THE BUDGET AMONG MEETING THE NEEDS OF THE COMMUNITY.
- EMERGENCY MANAGEMENT CONTINUING TO SUPPLY THE FIRST RESPONDERS WITH PERSONAL PROTECTIVE EQUIPMENT; MONITORING THE TEN (10) LONG TERM CARE FACILITIES IN CARBON COUNTY STATUS ON A WEEKLY BASIS.
- MAUCH CHUNK TRUST COMPANY AND JIM THORPE NEIGHBORHOOD BANK INFORMING THE PUBLIC THEY ARE PREPARED FOR THE ADDITIONAL RELIEF FUNDING REGARDING THE PAY CHECK PROTECTION PROGRAM; THANKED MAUCH CHUNK TRUST COMPANY AND JIM THORPE
